VIOLATIONS BUREAU SCHEDULE OF FINES

Pursuant to 479.050, RSMo and consistent with Supreme Court Rule 37.495, the Municipal Judge of the City of Manchester hereby orders that the following designated offenses shall be payable to the City of Manchester Violations Bureau. In such cases, no court appearance is necessary.

The Violations Bureau is established as a convenience to the public. It is not intended to replace a court appearance for pleas of Not Guilty. If you believe that you are not guilty of the offense charged, you should appear in court on the court date indicated on your summons.

In accordance with Missouri statutes and ordinances adopted by the City, total courts costs shall be \$31.50. This includes Basic Court Costs of \$12.00, Crime Victims Compensation surcharge of \$7.50, Law Enforcement Training Fund surcharge of \$1.00, Peace Officers Standard Training Fund surcharge of \$2.00, a Domestic Violence Shelter Fund surcharge of \$2.00 and a Court Automation Fee of \$7.00, for a total of \$31.50.

The following fines and costs have been established for the City of Manchester for offenses issued on or after January 1, 2020 and until further notice.

A MESSAGE FROM THE MUNICIPAL COURT

- You have been summoned to come to Court on the date shown on your ticket.
- You may plead not guilty on the Court date and a later trial date will be set.
- You may plead guilty by mail for most charges or by coming to the Court to pay your fine during normal business hours or on your Court night.
- If you plead guilty at Court, you will be given a future date to pay if you can't pay the day of Court.
- If you want to plead guilty, but you don't have the funds to pay your ticket, you must still come to Court on the Court date shown on your ticket. You will not be arrested for not having money to pay your fine.
- If you do not come to Court when summoned to do so, a warrant for your arrest may be issued.

INSTRUCTIONS TO PAY BY MAIL

1. Make check or money order payable to CITY OF MANCHESTER • DO NOT SEND CASH.
2. PLEASE SIGN THE BACK OF YOUR TICKET.

FAILURE TO APPEAR ON COURT DATE OR PAY FINE BEFOREHAND MAY RESULT IN A WARRANT
